TITLE: Ordinance Listing 2025 P Street (Levi Vandercook House) as a Landmark on the Sacramento Register of Historic and Cultural Resources (M24-003)

LOCATION: 2025 P Street (007-0246-005-0000); District 4, Represented by Councilmember Valenzuela

PROJECT: A public hearing by the Preservation Commission to review a historic landmark nomination for the Levi Vandercook House at 2025 P Street. The Preservation Commission will make a recommendation to the City Council, who will make a final decision. A public notice will be sent in advance of each hearing.

ENVIRONMENTAL: The listing of the Nominated Properties as individual landmarks on the Sacramento Register is exempt from review under the California Environmental Quality Act pursuant to CEQA Guidelines section 15308.

If you challenge the nature of the proposed action in court, you may be limited to raising only those issues you or someone else raised at the Public Hearing described in this notice or in written correspondence delivered to the Preservation Commission at or prior to the Public Hearing.
